**Re:** Information Regarding the Adoption of Budget Amendments

I received an email from Councilman Stimatz requesting information concerning budget amendments, which had been proposed this fiscal year. Specifically, Councilman Stimatz wanted to know how many budget amendments were not approved and how many were approved directly from the Consent Agenda. In addition, he requested to know which ones were removed from the Consent Agenda and what the vote on each budget amendment was.

Attached, you will find a spreadsheet put together by staff. All budget amendments were approved by a unanimous vote of the City Council. Budget amendments fall into three categories: (1) those placed on the Consent Agenda and approved; (2) budget amendments removed from the Consent Agenda and approved during the Regular Agenda; and (3) Budget amendments, which were placed on the Regular Agenda for action.
