Consideration - Bid Opening for Route 17 S Sidewalk Project

BACKGROUND:

The City would like to build a sidewalk between Providence Road and the entrance to the Farm Fresh shopping area near Applebee's. The project has been designed and reviewed for compliance with NCDOT requirements as required by the terms of a Municipal Agreement. Construction bids were opened for a third time on October 22, 2013. The first two times the project was approved by NCDOT and bid, there were problems. The first time the project was bid, the low bidder was disqualified by NCDOT. The second time, the bids were almost double the project estimate. The project has been subsequently redesigned to allow the contractor flexibility in the design of the pedestrian bridge, which is part of the project.

With the above referenced Municipal Agreement, the City has secured \$85,000 in enhancement funds through Section 1201 of the Transportation Equity Act of the 21st Century (TEA-21) for the construction of this sidewalk project.

ANALYSIS:

The RPC Contracting bid of \$99,937.00 was the apparent low bid for the construction of the Route 17 South Sidewalk Project. The other bids received were:

Barnhill Contractors, Inc.

\$105.818.00

Carolina Marine, Inc.

\$151,036.00

A copy of the construction bid analysis is attached.

The total project cost including the balance of engineering design cost is anticipated to be \$105,000. The project will be funded through the \$85,000 enhancement grant from NCDOT with the balance of the cost (\$20,000) being paid from the City's Powell Bill Funds.

STAFF RECOMMENDATIONS:

By motion, recommend that the City Council adopt the attached resolution authorizing the City Manager to enter into a Construction Contract with RPC Contracting, Inc. in the amount of \$99,937.00 for the construction of the Route 17 South Sidewalk Project, subject to final approval of the proposed construction bid by NCDOT;

and further, recommend that the City Council adopt the attached budget amendment for this project.

NOW, THEREFORE , be it resolved that the City Council hereby authorizes City Manager Rich Olson to enter into a construction contract with RPC Contracting, Inc. in the amount of \$99,937, pending concurrence by NCDOT, for the construction of the project described herein.

BUDGET AMENDMENT
