Background:

Currently there is a vacancy on the Board of Zoning Adjustments. Mr. Robert E. Thorne of 2066 Rivershore Road, Elizabeth City has expressed a desire to serve on this board.

Analysis:

The Board of Zoning Adjustments has a total of ten members with six being appointed by the City Council and four appointed by County Commissioners. Terms are for a three year period. I am asking that you confirm his appointment to a three year term ending September, 2016.
