REF: Consideration – Award of FY 2013-2014 Chemical Bids

BACKGROUND:

Annually, the City solicits bids for the purchase of chemicals used at the Water Treatment Plant (WTP) and Wastewater Treatment Plant (WWTP). For the upcoming fiscal year (FY 13/14), chemical bids were received through the purchasing office.

ANALYSIS:

The following is a summary of the low bidders for the chemicals. Attached is the Bid/Quote Summary as prepared by purchasing, which shows all the bids received.
