Consideration - Acquisition of Right of Way by NCDOT on former Rice

property

## **BACKGROUND:**

Included on the Finance Committee agenda for consideration is a request by NCDOT to acquire two rights-of-way from the City to construct the South Road Street Bridge. NCDOT also needs to acquire a strip of property from the property owned by Tony and Tammy Rice, which the City has under contract. The City Attorney has scheduled the closing on the Rice property for 11:30 a.m. on Friday, October 4, 2013.

At that time, the City will control a third piece of property that NCDOT needs for right-of-way purposes. I have already executed a Right of Entry form to allow NCDOT to conduct certain soil borings and other work. NCDOT has offered Mr. Rice (and now the City) \$4,675 to acquire a section of this property. City staff met with NCDOT on October 1, 2013 to discuss the bridge project and how and where the City would tie Herrington Road in to South Road Street.

NCDOT has prepared all legal documents for the conveyance of the property by Tony and Tammy Rice. Once the City's deed is recorded, they will generate new documents in the City's name.

Staff is asking the Council to approve the sale of a section of property presently owned by Tony and Tammy Rice that will be acquired by the City to NCDOT in the amount of \$4.675.

## STAFF RECOMMENDATION:

By motion, recommend that the City Council authorize Mayor Joseph W. Peel to execute all documents required for the sale of property, (which will be acquired by the City from Tony and Tammy Rice), to NCDOT in the amount of \$4,675 by adoption of the attached resolution.
