**Re:** Consideration – River City CDC Summer Youth Camp Funding

### **BACKGROUND:**

During the March 23, 2015 Regular Session, the City Council considered revision to the River City CDC Summer Youth Camp programming as it affects the use of previously awarded Community Support Grant monies. Decision to approve the requested reallocation of Community Support Grant funding for River City CDC was tabled at this meeting with directive to staff to provide additional program information from the River City CDC organization.

### **ANALYSIS:**

Previously staff reported to City Council that the proposed use of funds is substantially different from River City CDC's presentation to the Finance Committee during the Community Support Grant process. Attached is communication from the organization reporting the total budget for building supplies and materials is \$18,500. Of this total \$8,500 are funds awarded by City Council through the Community Support Grant process. A second document from River City CDC lists the property locations for the 2015 Youth Work Camp initiative. Of the 33 individual properties listed, 17 are within the Elizabeth City municipal limits. Using the information reported, River City will average \$500.00 per structure. Data from the 2013 program year indicates a total of \$5,000 in building supply funds and a total of 36 Elizabeth City work sites served; averaging \$139 per structure. If the whole project is considered - total funding and total number of structures affected, the cost per structure averages are: \$561 for the current 2015 project year and \$444 (actual) in the prior 2013 project year.

In consideration of the above averages, the requested funding amendment is justified. Moreover, there are intangible benefits to the Work Camp project that will further motivate and endear the youth participants to making Elizabeth City a community.

### **FINANCIAL**:

The Finance Committee discussed this matter during their meeting of April 9, 2015. Upon motion by Mayor Peel, seconded by Councilman Donnelly, the committee unanimously recommended forwarding the matter to the full City Council's regular agenda for April 13, 2015 with a recommendation of approval.

### STAFF RECOMMENDATION:

By motion, approve the requested reallocation of Community Support Grant funding for River City CDC.

This year River City CDC will sponsor a Youth Work Camp project similar to the Group Work Camps that we have sponsored in recent years. These projects provide nocost home repair to elderly, disabled, veteran, and/or low-income individuals who are homeowners. Repairs range from window repair and replacement, interior and exterior painting, repairing/building porches and handicap ramps, etc. The difference in our camp this year is that it will be a completely local effort. Rather than youth and adult volunteers from across the nation, our Youth Work Camp 2015 will involve local youth and adult volunteers giving back to their community by performing the repairs on these homes.

The revised budget for this project is as follows: the total budget for building supplies and materials will be \$18,500. Of this total, \$10,000 will come from River City CDC, and \$8,500 that the City of Elizabeth City had previously approved for our work camp this year. The funds appropriated by the city will be used to repair homes in Elizabeth City and benefit its residents.
